under Section 8 (1)(b)(11) of the Welsh Church Act, 1914, transferring the burial ground adjoining the Church of St. Tydecho in the Parish of Llanymawddwy in the County of Merioneth to the Parish Council of Llanymawddwy.

WHEREAS under Section 4 (1) of the Welsh Church Act 1914 it is provided that as from the date of disestablishment there shall save as by that section provided vest in the COMMISSIONERS OF CHURCH TEMPORALITIES IN WALES (therein referred to as "The Welsh Commissioners") (a) ALL property vested in the Ecclesiastical Commissioners or Queen Anne's Bounty which was ascertained as thereinafter-mentioned to be Welsh Ecclesiastical property and (b) ALL property not so vested and not consisting of charges on the Common Fund

of the Ecclesiastical Commissioners which at the passing of that Act belonged to or was appropriated to the use of any Ecclesiastical Office or Cathedral Corporation of the Church in Wales or the holder of any such office as such subject in the case of all such property to all tenancies charges and incumbrances and to all rights and interests saved by that Act affecting the property

AND WHEREAS under Section 8 (1)(b)(ii) of the said Act it is provided that, subject to the provisions thereof, of the property not transferred to the Representative Body of the Church in Wales the Welsh Commissioners shall transfer the burial ground of any ecclesiastical parish so as to vest the same in the existing incumbent during his incumbency and on the determination thereof where the burial ground is situate in a rural parish, or in a part of a rural parish in which the Burial Acts, 1852 to 1906, are not in force, in the council of that parish, or, if there is no council, in the Chairman of the Parish Meeting and Overseers of that parish;

AND WHEREAS under Section 2 of the Welsh Church (Temporalities) Act 1919 the date of disestablishment was the 31st day of March 1920;

AND WHEREAS the whole of the graveyard adjoining the Church of St. Tydecho in the parish of LLANYMAWDDWY in the County of Merioneth is now vested in the Welsh Commissioners under Section 4 (1)(b) of the said Act and being a burial ground within the meaning of the said Section 8 (1)(b)(ii) is accordingly transferable under the provisions of that section;

AND WHEREAS there is no existing incumbent in the said parish of LLANYMAWDDWY within the meaning of the Welsh Church Act 1914;

AND WHEREAS at a meeting of the Parish Council of LLANYMAWDDWY duly convened and held on the 9th day of June, 1924, it was resolved that the transfer intended by this Order to be effected should be accepted by the said Parish Council;

NOW THEREFORE in pursuance of the provisions of Section 8 (1) of the said Act the Welsh Commissioners do by this Order transfer ALL that burial ground adjoining St. Tydecho's Church in the Parish of LLANYMAWDDWY in the County of Merioneth delineated on the attached plan and coloured purple thereon

together with the pathways on the same also delineated on the said plan and thereon coloured brown to the LLANYMAWDDWY PARISH COUNCIL to be held by them subject to all easements rights privileges and quasi easements liabilities and public rights (if any) affecting the same and particularly to the rights and obligations specified in section 24 of the Act of 1914 in so far as the same are or may hereafter become applicable;

IN WITNESS WHEREOF WE the said Commissioners of Church Temporalities in Wales have hereunto caused our Common Seal to be affixed this 24 day of April ---- One thousand nine hundred and twenty five.
